#### **Background**

In March of each year, the City Manager formally presents the proposed budget to City Council and the public. This is followed by a series of public hearings, work sessions, a community budget forum and a final vote on the budget no later than April 15<sup>th</sup>. This item begins the FY 2024 budget discussions and deliberations.

#### **Discussion**

The total General Fund Budget for FY 2024 is proposed to be **\$226,239,155**, a **6.27%** increase over FY 2023. The proposed budget also includes a **\$98.9 million** Capital Improvement Program budget in FY 2024. The new online Budget Book and presentation materials will be posted online after the meeting adjourns.

#### Alignment with City Council's Vision and Strategic Plan

The proposed budget aligns with the City's current Strategic Plan which has been extended to FY 2024.

#### **Community Engagement**

The presentation will be in-person in Council Chambers and up to 23 pre-registered members of the public and two media representatives may register to attend.
