Convened 1205 NDS Conference Room. Quorum Declared. See roster for attendance.

Nick Burke (sp?) new housing coordinator, absent
Pethia request to adjust previous notes, Dan vote to approve with Pethia adjustment,
Lyle second, passes
Chris Meier, new LEAP rep attending

Sunshine Mathon updates on RFP, PC info still needed, Lyle is working on this IAT update from Sunshine: need to get staff up to date with IAT, integrate with CIP, four or five person group, Sunshine, Ridge, Rory from PC, Mike Murphy, Brenda Kelley (will be Nick), new CIP starts in September, final version needed by August, body has met once

Presentation / Report on CSRAP - Grant Duffield

Started as recommendation from RCLCO study, "low hanging fruit" in 2017, intended to provide a dataset to learn from, segmented to compare, started as a pilot, intended to house 125 families at start with \$900,000 in funding, started in Feb. 2018. That money timed out in June 2018. A four month extension was possible if the next year's funding was cut. Available to 60% of AMI or less. Three buckets: "Family self-sufficiency programs", chronically homeless slots, Housing Choice Voucher waiting list clients.

Served 89 families total. 77 receiving now. 250 people housed. 105 adults. 2 elderly, 24 disabled. No new families allowed, out of funding. Families must live or work in Cville. 90 day search, then 90 day extension allowing County.

\$477,544 spent. \$2,456 left. Monthly rental expenses are \$49,875 a month. Projected to spend \$547,294 by June 2019

Average rental assistance: \$647.72 Projected Year 2 need: \$650,000

1.10% of current monthly expense. No increase in # of families served

Hill: this is funded, Grant confirms, Dan confirms

Discussion of whether to push reserve forward, drop it, or double it. Sunshine: extend it. Hill: We have multiple years already budgeted, not hold money unnecessarily.

Grant: Plenty of funding

Joy Johnson: People with vouchers want to know what will happen next year. What will we do to maintain existing people worrying.

Hill: We have funding for 24 months

Alex: CRHA has to submit a request for appropriation for second year

Brenda: This year has been set aside but CRHA has not requested it

Grant: Disagree.

Alex: This was intended for 24 months. There is a provision that CRHA must request

additional funding, must go through Council appropriations

Brenda: Working on this for May 6 Council agenda

Phil: Was a desire to guarantee that vouchers would be good for 24 months. Was reengineered at midnight to do this, not perfect. Need to reconfigure math to expand it. Grant: Would be helpful.

Hill: Could be more, surplus. 2019 funds have not been used. Needs to be allocated.

Dan: Council needs to decide what to do with the money.

Grant: \$315k reserve, 30-40 families waiting list

Chris: Are some families having trouble finding a place? Grant yes

37% of recipients reside in City, (Brenda and Grant disagree)

Chris: We have money for this.

Sunshine: C3 wants to do this (Charlottesville Coimate Collaborative) align climate

action with equity, require vouchers to receive efficiency upgrades

Lisa: zoning and ADUs, I'd do that

Anthony: only two vouchers of ten have gone to homeless

Dan: Homeless (10), family self sufficiency (20 all went, question on efficacy), overall utilization rate question (ability to find a home),

Sunshine: How many tried to find a place in the City vs County

Dan: AMI range, Council wanted to push this down, inflexible, can prevent, all below 30%? No funding for CRHA? Burden?

Grant: Costs \$25k programming a year for inspections and admin, can absorb it, good thing, helps address waiting list backlog, can migrate CSRAP to HCB program in future

Dan: Fiscal year? Funding preauthorized to prevent disruption?

Grant: Money is allocated, no contract. Don't know where that falls.

Alex: Recommend in update to Council, highlight Dan's questions, discuss challenges, may be recommendations for changes, may include admin funding, Council wants outcome, benchmarks

Phil: Policy subcommittee can work on this

Brenda: Agenda item is due late Friday

Grant: Can pull data together in time, easy

Dan: Don't want Policy to slow this down Brenda: Policy could meet next week

Phil: Need someone to lead, write up a memo

Hill: Policy input would be helpful, want to understand the hurdles from helping more people

Phil: May revise bands established

Hill: Want to use money to best meet the needs of the most people

Brenda is the memo developer for Council presentation

Joy: Need to iron out 24 month issue before we expand, people are panicking it will go away. Need to make those people comfortable, afraid they need to move away soon.

Phil: Money process was not carefully considered, needs revision, have \$1.8 million

unspent here. How fast can we grow it with security? Inventory constraint?

Dan: We don't know the constraints yet.

Lyle: Do we know now that people don't need to move?

Grant: Money is available, don't know process

Dan: Need appropriation and contract to make it happen

Joy: Where is the money?

Brenda: It's in the CAHF right now. Can change buffer from 4 to 6 months

Jennifer: Was there going to be a time limit? Grant: We don't have funding for 24 months

Sunshine: Is there a limit on how long any person can use funding?

Grant: No

Joy: People were told this was 12 month funding. They are scared the money is going away

Phil: Political background explanation, need for buffer

Hill: Had funding the prior fiscal year and all of this year. We already had enough to do 24 months budgeted. Priority, then what more can we take on.

Phil: The math works,

???: Tenants need clarity.

Anthony: Need to understand pipeline, glad to see self sufficiency program is moving people through to not needing subsidy

LD: Need to be strategic, programmatic, self sufficiency is dependent on self development, table to get a fish

Joy: Affordability is a big problem when people make money, lose access to vouchers, forced to move to worse housing

Phil: No requirement to recertify income in this program, no penalty for earning, but can get more help if needed, 24 month look back

Jov: 12

Grant: up to 24

Joy: 12

Phil: Turnover is a good thing here

Joy: Not mirroring Section 8 program here, people's income changes, there's not a penalty

Phil and Dan: Y

Hill: Why is there a problem here? We have funding for 24 months.

Phil: 125 vouchers were intended for one year at first. Then Council would extend the next year. That moved to 24 month model

Jennifer: Will create a new contract?

Alex: Existing contract will be modified for one more year.

Dan: People are nervous, we need to say something to them. Money is allocated. CRHA needs to update the contract to spend the money. We can tell people they're okay.

Hill: We fixed this last budget year. We're in the third year now. Frustrating.

Lisa: The money is there, contract was the problem? Money has come in a third year, why isn't someone showing up at a Council meeting to use the money?

Grant: We're doing this on the 6th. We have the money. Asked City Manager and Staff for update, don't know if it's allocated.

Alex: You have to request it if you want to use it.

Grant: Y

Hill: I think this is an easy thing.

Frank: Do we need to take an action on this?

Phil: Policy will.

Lyle: move to send this to Policy subcommittee to fix

Lisa second

Joy: I hear a couple of breakdowns. Housing authority deadline is coming up. Why isn't there better communication? Listening to what's not being said. Breakdown between city and housing authority. We are serving families. Don't know if Policy committee can fix this. PHAR deals with similar problems, gets notice.

Hill: Brenda how does that happen?

Lyle agrees to amend motion to also address logistics and procedures

Dan: Policy committee doesn't do city procedure

Alex: This is the city and CRHA's responsibility, must be requested by CRHA in writing, staff would write up a staff report

Lyle: Amend to remove procedure from policy subcommittee

Motion passes, unanimous

Hill: Quotes written agreement detailing procedure, asks Brenda to clarify

Brenda: Staff has provided many notices, as required

Grant: I haven't received any schedule from budget director, will do this thing, quarterly reporting has been completed, sent to Mike Murphy,

Hill: We have to work better together

Grant: Thank you to this group for coming up with this concept, pushed hard to get it done, have served a bunch of people, kept people from homelessness, thanks to PHAR. Legal Aid

Dan: Thanks for administering this at no cost, need to do more

Anthony: Need some additional info for homeless performance in data dump. Don't know why only 2/10 used them, have more people in need, want to get those unused vouchers revolving

Grant: Went through Region 10 Anthony: We'll work on this

Hill: Want agreement on data, no discrepancies

Public Comment:

Brandon Collins, PHAR: Need to free up waiting list, want to see if there has been movement in waiting list, expect hasn't, need to be commitment, larger strategy will make this more effective, want more permanent stage, need coordination between housing waiting lists, Housing Choice Vouchers are more permanent, can free up waiting list, about 1200 families across all waiting lists. Need to do more.

Dan: Aren't the next coming from CRHA waiting list?

Brandon: Yes. No other option to help people on the CRHA waiting list, locked up. Bigger opportunity isn't happening.

Dan: Came from understanding that 1600 waiting list back in the day was a serious problem. Need a dynamic ladder of opportunity.

Brandon: This could be a step up, currently an endpoint.

Subcommittee Updates – respective chairs

Dan: Policy hasn't met, will work on this offline Sunshine already updated on Strategy. IAT etc.

Allocations: Waiting to know what we have. Need to talk to Nick.

Hill: Have to look at balance, July 1 and December allocations. First guaranteed and then second "very likely"

Discussion on last year's Allocation results, needs update on scoring, LIHTC issues Sunshine: Needs work before next round Y?

Trish: Y

Joy: People upset about comments about Section 8 residents behavior, need to be cleaner. We are serving people here. Many have illnesses, don't necessarily need to be taught how to clean, don't have cleaning staff. People have challenges.

Lisa: was said in the vein of informing landlords that Section 8 residents are fine tenants LD: Something was lost in translation, remember discussion about landlords,

Joy: Asking everyone to be mindful

Anthony: Offering new technical assistance program "ARK?" coming soon LD: Concept of self sufficiency (different from income), is HAC not the place for that discussion? If not, where is? Money is allocated. Does this group make policy decisions?

Phil: Y

Lyle: Policy subcommittee does that y?

Phil: Y, but not exclusive, usually a specific issue

Dan: New event coming, Regional Housing Partnership. June 12 press conference National advocacy campaign on housing. 1/6 Americans pay over 50% of income on housing. Want national reform. About total cost, including rentals and ownership.

Public comment:

Brandon, PHAR: Belmont apartments issue, running counter to all efforts, similar happened on Stribling, could have been better if renters knew about resources, need to do better,

Emily Dreyfus, Legal Aid/PHAR: Need to map out existing private capacity, figure out what's vulnerable, get ahead of the problem

Phil: Stacy created this 18 months ago

Alex: LIHTC, etc, need license to rent, useful dataset, Virginia is a tough state for

renters' rights Hill: Adjourn, Lyle second, pass unanimous
