- Welcome
 - Josh Bowers is running the meaning
- Acceptance of Minutes
 - August 25 and September 11 meeting minutes are adopted.
 - o Acceptance of minutes is unanimous
- Community Input
 - Jeff Fogel
 - Friday, received a response to a complaint filed against officer (Filed in June)
 - Chief promised 30 days to respond; Rules say 45 days to respond; It took 90 days.
 - Rules require an investigating officer draft a member explaining justifications of findings by IA and Chief
 - Jeff wrote back to Chief and Head of IA no response.
 - Jeff reached out to City Attorney on Friday and hasn't heard back from him yet.
 - Stop and Frisk: new computer system does not allow them to identify the fields that would identify
 - Who was responsible for making sure that this data got transferred or the method of collecting data wasn't transferred?
 - **Issue to consider: should we have the police complaint form on our website if the dept is not responding appropriately and in a timely manner to complaints?
 - **Josh: can address this issue directly with the Police Dept through meetings with the Chief
 - Discussion re: similarity to CPD's response to Katrina Turner's complaint
 - Letter from Chief Brackney to Katrina Turner was read aloud.

Walt Heineicke

- Disturbed that Stop and Frisk data is not being collected
 - o breach of public trust
 - Should be taken into consideration in CRB's Bylaws
 - Significant urgency should be communicated to council

- Council should conduct an independent 360 review of the organizational culture of the police department (good idea for the new chief to have)
 - o Done under council's supervision
 - Culture needs to be examined and re-evaluated

Further discussion re: Stop and Frisk/Investigative Detention Data:

- Jeff Fogel:
 - o CPD used to use PISTOL
 - They're saying that Alb, UVA, and Cville using same new system and Alb and UVA not collecting this data, so it slipped through cracks
 - o No longer collecting the data.
